1998 CENSUS OF AQUACULTURE

The census of aquaculture contains statistics about the Nation's aquaculture production and presents information on the structure of the aquaculture industry at the national, regional and state levels. The aquaculture census collected detailed information relating to on-farm aquaculture practices, size of operation based on water area, production, sales, method of production, sources of water, point of first sale outlets, cooperative agreements and contracts, and aquaculture distributed for restoration or conservation purposes.

The Nation's first census of aquaculture revealed that the industry is indeed one of agriculture's fastest growing sectors. The value of aquacultural products sold continues to grow, increasing over 20 percent from 1997 to 1998; sales totaled \$807 million in 1997, then rose to \$978 million in 1998. With \$290 million, Mississippi topped the sales charts, accounting for nearly 30 percent of domestic aquaculture produced in 1998. Maine, at \$66.6 million, ranked fourth in sales. If the six New England States were treated as one state, their total of \$91.2 million in sales would rank second in the Nation.
